

UNDERGRADUATE NON-DEGREE APPLICANT:

Definition-

An applicant with a high school diploma (with the exception of a high school concurrent enrollment participant) who wishes to take specific undergraduate coursework and does *not* wish to pursue a degree at Texas A&M University.

Priority is given to qualified applicants for their initial bachelor's degree; therefore, non-degree admission may be limited or not available.

<p><i>All materials must be received by the application deadline.</i></p> <ul style="list-style-type: none"> • State of Texas <i>ApplyTexas</i> Application – Completed. www.applytexas.org * Please select the Transfer Undergraduate Application when applying online. • Nonrefundable Processing Fee \$60 Spring 2013, and \$75 beginning Summer 2013 as a domestic applicant. Credit Card payments may be charged minimal, nonrefundable transaction fee. • If requesting a Fee Waiver, must submit documentation of need from a financial aid advisor at your current school. • Essay topic B is required – the Statement of Purpose essay. Explain why enrollment at Texas A&M University is necessary, and describe the goals you wish to accomplish if admitted, including the courses in which you would like to enroll. (Essay topic C is optional). • A complete, official transcript from the latest and last college attended or high school if the applicant has not attended college. Must be mailed in a sealed school envelope or submitted electronically from the institution attended. • If permanent resident, must submit a copy of both sides of the permanent resident card or I-485 prior to enrollment. If application is in process please provide copy of I-797. If under 18, a copy of the parent's permanent resident card is also required. • If Texas resident based on SB 1528, must submit the SB 1528 affidavit prior to enrollment. • All students under age 30 entering an institution of higher education (public or private) must provide proof of bacterial meningitis vaccination within the last 5 years.
