Complete application files are reviewed by the academic colleges. Admission decisions are based on information presented in the application and statement of purpose and continued enrollment is subject to review at the end of each semester of enrollment.  NOTE: The College of Liberal Arts and Biomedical Sciences do not consider NDS applicants.
•	If requesting a Fee Waiver, must submit documentation of need from a financial aid advisor at your current school. Documents may be uploaded in the Applicant Information System (AIS).  Essay topic B is required – the Statement of Purpose essay. Explain why enrollment at Texas A&M University is necessary, and describe the goals you wish to accomplish if admitted, including the courses in which you would like to enroll. (Essay topic C is optional).  A complete, official transcript from the latest and last college attended or high school if the applicant has not attended college. Must be mailed in a sealed school envelope or submitted electronically from the institution attended. See admissions.tamu.edu for acceptable electronic transcript providers. •	If permanent resident, must submit a copy of both sides of the permanent resident card or I-485 prior to enrollment. If application is in process please provide copy of I-797. If under 18, a copy of the parent's permanent resident card is also required.	
•	If Texas resident based on SB 1528, must submit the SB 1528 affidavit prior to enrollment.	
•	All students under age 22 entering an institution of higher education (public or private) must provide proof of bacterial meningitis vaccination within the last 5 years. More info provided at admissions.tamu.edu/meningitis.aspx.
