

UNDERGRADUATE NON-DEGREE APPLICANT:

Definition-

An applicant with a high school diploma (with the exception of a high school concurrent enrollment participant) who wishes to take specific undergraduate coursework and does *not* wish to pursue a degree at Texas A&M University. *Priority is given to qualified applicants for their initial bachelor's degree; therefore, non-degree admission may be limited or not available*

<p style="text-align: center;"><i>All materials must be received by the application deadline.</i></p> <ul style="list-style-type: none"> • State of Texas <i>ApplyTexas</i> Application – Completed. www.applytexas.org Please select the Transfer Undergraduate Application when applying online. • Nonrefundable Processing Fee \$75 as a domestic applicant. Credit Card payments may be charged minimal, nonrefundable transaction fee. • If requesting a Fee Waiver, must submit documentation of need from a financial aid advisor at your current school. Documents may be uploaded in the Applicant Information System (AIS). • Essay topic B is required – the Statement of Purpose essay. Explain why enrollment at Texas A&M University is necessary, and describe the goals you wish to accomplish if admitted, including the courses in which you would like to enroll. (Essay topic C is optional). • A complete, official transcript from the latest and last college attended or high school if the applicant has not attended college. Must be mailed in a sealed school envelope or submitted electronically from the institution attended. See admissions.tamu.edu for acceptable electronic transcript providers. <p>Documents required for enrollment:</p> <ul style="list-style-type: none"> • If permanent resident, must submit a copy of both sides of the permanent resident card or I-485 prior to enrollment. If application is in process please provide copy of I-797. If under 18, a copy of the parent's permanent resident card is also required. • If Texas resident based on SB 1528, must submit the SB 1528 affidavit prior to enrollment. • All students under age 22 entering an institution of higher education (public or private) must provide proof of bacterial meningitis vaccination within the last 5 years. Admission decisions are based on information presented in the application and statement of purpose and continued enrollment is subject to review at the end of each semester of enrollment.</p> <p>NOTE: The College of Liberal Arts and Biomedical Sciences do not consider NDS applicants.</p> <p><u>Examples of Applicants</u></p> <p>Local residents or University employees taking courses on a part-time basis.</p> <p>Applicants completing established Texas A&M University requirements for teacher or other certification</p> <p>Applicants completing a prescribed set of courses as preparation for application to graduate study or professional programs (i.e. medical school, veterinary school, law school or CPA exam); and</p> <p>Others as deemed appropriate by the Office of Admissions and the college program of admission</p>
